FACTS	WHAT DOES BCU DO WITH YOUR PERSONAL INFORMATION?
Why?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.
What?	<ul> <li>The types of personal information we collect and share depend on the accounts, products or services you have with us. This information can include:</li> <li>Name, address, Social Security Number, and income</li> <li>Account balances and payment history</li> <li>Credit history and credit scores</li> </ul>
How?	All financial companies need to share members' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their members' personal information; the reasons BCU chooses to share; and whether you can limit this sharing.

Who is providing this notice?	BCU.
What We Do	
How does BCU protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards, secured files and buildings, procedural safeguards and safe record storage. We will continue to review and modify our security controls in the future to deal with changes in products, services and technology.
How does BCU collect my personal information?	<ul> <li>We collect your personal information, for example, when you:</li> <li>open an account</li> <li>apply for a loan</li> <li>use your credit or debit card</li> <li>pay your bills</li> <li>make deposits to or withdrawals from the accounts you have with us</li> <li>We also collect your personal information from others, including credit bureaus or other companies.</li> </ul>
Why can't I limit all sharing?	<ul> <li>Federal law only gives you the right to limit:</li> <li>sharing for affiliates' everyday business purposes—information about your creditworthiness</li> <li>affiliates from using your information to market to you</li> <li>sharing for non-affiliates to market to you</li> <li>State laws and individual companies may give you additional rights to limit sharing.</li> </ul>
What happens when I limit sharing for an account I hold jointly with someone else?	Your choices will apply to everyone on the account you have with us.
Definitions	
Affiliates	<ul> <li>Companies related by common ownership or control.</li> <li>They can be financial and nonfinancial companies.</li> <li>BCU has the affiliates, BCU Wealth Advisors, LLC and Life. Money. You., LLC.</li> </ul>
Non-affiliates	<ul><li>Companies not related by common ownership or control.</li><li>They can be financial and nonfinancial companies.</li><li>BCU does not share with non-affiliates so that they can market to you.</li></ul>
Joint marketing	<ul> <li>A formal agreement between non-affiliated financial companies that together market financial products or services to you.</li> <li>Our joint marketing partners include insurance companies, credit and debit card companies, mortgage companies, investment and brokerage firms, and other types of financial product and service companies.</li> </ul>

## **Other Important Information – Your Location Data**

Our websites and our Mobile Banking app periodically collect, transmit, and use geolocation information to support features such as determining your zip code, finding your nearest Branch or ATM and preventing fraudulent card use, but only if you authorize collection of such information.

On our websites, you can choose whether geolocation information can be monitored by clicking the "Allow" button when prompted. Using our Mobile Banking app, you may choose whether geolocation information can be followed on a continuous basis in the background, only while the app is being used, or not at all. You can change your location permissions at any time in your device settings.
