Promotional Period for Introductory APR:

The Introductory APR for purchases and balance transfers will apply to transactions posted to your account during the first 365 days following issuance of your card. Any existing balances on Baxter Credit Union DBA BCU loan or credit card accounts are not eligible for the Introductory APR for balance transfers.

Loss of Introductory APR:

We may end your Introductory APR for purchases and balance transfers and apply the prevailing non-introductory APR if you are 60 days late in making a payment.

Credit extended under this credit card account is secured by various personal property and money including, but not limited to: (a) any goods you purchase with this account, (b) any shares you specifically pledge as collateral for this account on a separate Pledge of Shares, (c) all shares you have in any individual or joint account with the Credit Union excluding shares in an Individual Retirement Account or in any other account that would lose special tax treatment under state or federal law, and (d) collateral securing other loans you have with the Credit Union excluding dwellings.

Other Fees & Disclosures:

Late Payment Fee:

\$29.00 or the amount of the required minimum payment, whichever is less, if your payment is not received by the next statement closing date. The next statement closing date varies by month from 4-6 days after your payment due date.

Balance Transfer Fee (Finance Charge):

3.00% of each balance transfer. However, this fee is waived on transactions posted to your account outside of a promotional period.

Cash Advance Fee (Finance Charge):

Either \$10.00 or 3.00% of the amount of each cash advance, whichever is greater.

Returned Payment Fee:

\$29.00 or the amount of the required minimum payment, whichever is less.

Rush Fee:

\$30.00 next business day. \$20.00 second business day.

Statement Copy Fee:

\$2.00.
